

## Call for Applications

### FOR THE NATIONAL HIGHER EDUCATION SCHOLARSHIP FOR THW 2026/2027 ACADEMIC YEAR

The Minister responsible for Higher Education awards a national higher education scholarship for a period of one academic year (10 months) to students who have achieved outstanding academic and professional performance, as a financial recognition of their achievements and to support their continued success.

The rules governing the awarding of national higher education scholarships are set forth in Act CCIV of 2011 on National Higher Education (hereinafter: Nftv.) and in Government Decree No. 51/2007. (III. 26.) on the benefits of students in higher education and certain fees payable by them (hereinafter: Government Decree).

Applications for the National Higher Education Scholarship can be submitted by those students of the University who are enrolled in a full-time bachelor's, master's, or single-cycle degree program holding weather state scholarship, or are self-financed students, if they:

- have been enrolled for at least two semesters during their current or previous studies and have earned at least 55 credits;
- have achieved a minimum of 4.3 scholarship average in each of their last two completed active semesters;
- have demonstrated outstanding performance in professional, public, sport, cultural, or other fields.

The scholarship may be granted for the duration of a full academic year, or 10 months. Its value is HUF 40 000/person/month.

Students are eligible for the scholarship during the 2026/2027 academic year. If the student's enrollment status is terminated or suspended, the national higher education scholarship cannot be disbursed to them (following the termination of enrollment status, if the student does not establish enrollment status in a bachelor's, single-cycle, or master's program for the 2026/2027 academic year; or during the period of suspension of student status).

Students may submit their applications by email until Thursday, July 9, 2026, to [nfo@uni-mate.hu](mailto:nfo@uni-mate.hu).

Applications may be submitted by submitting the application form with supporting documents verifying professional, public, athletic, cultural, and other activities. The student must sign the application and indicate on each attached document which eligible activity the supporting document verifies. Applications submitted without a signature are invalid, and signatures edited to the application form or other supporting documents will not be accepted.

It is the student's responsibility to ensure, in all cases, that any document received and submitted as proof meets the required standards in terms of both content and form.

The scoring system for applications and the procedures for submitting verifying documents are set forth in Appendix 3 of the Regulations on Student Fees and Benefits, which is available on the University's website [PDF](#).

The Educational Coordination Office will fulfil the scholarship average points on submitted applications; therefore, no verifying documentation is required.

The Senate will decide on the ranking of the applications by July 31, 2026.

Following the decision, the Vice Rector for Education will notify the applicants of their scores, as well as whether the University Senate has recommended them for the scholarship based on their ranking (notification of the decision).

An appeal against the Senate's decision may be submitted within 15 days of the decision's notification, addressed to the University Student Appeals Committee at [hfb@uni-mate.hu](mailto:hfb@uni-mate.hu). The appeal must be submitted by indicating the exact provision of the relevant university document violated during the calculation of scores.
